Textual Information(1)	The shares have been issued and allotted to the new promoters by the Board of Directors of the Company at their meeting held on 03rd February 2023 pursuant to Resolution Plan approved by NCLT vide its order dated 25th June 2021 read with corrigendum order dated 10th July 2021. As a result of the NCLT order the promoters shareholding has increased to 95% and public shareholding has fallen to 5% from 02nd March 2023. The NCLT has directed the Company to increase the public shareholding to 10% within a period of 1 year and to 25% within a period of 3 years. In this regard, all the statutory payments are in order and the Company is actively working towards increasing the public shareholding to the statutory requirement.
